REPORT ON THE MONITORING OF ARMENIAN BROADCAST MEDIA COVERAGE OF THE DECEMBER 6, 2015 REFERENDUM ON AMENDMENTS TO THE RA CONSTITUTION

(October 26 - December 4, 2015)

The coverage of the campaign preceding the December 6, 2015 referendum on amendments to the RA Constitution by six Armenian national TV channels, which were included in the study, was in general consistent with the national legislation on referendum. Certain deviations from balanced coverage prescribed by relevant regulatory acts can be explained not by the policies of the studied channels per se, but rather by the passivity of some participants of the promotion campaign, as well as by the traditionally wide coverage of all the rare occasions when the head of state communicates with the media.

TV viewers, interested in the topic of the constitutional reform, had an opportunity to get acquainted to various opinions regarding the suggested amendments to the Constitution. Broadcasters aspired to form their programmes in such a way that a certain position voiced regarding the draft would be balanced by the opposite opinion. On two TV channels monitored (First Channel of the Public Television of Armenia and "Armenia") this was achieved also through the coverage of the reality show "Yes and No", initiated by the TV companies "ArmNews" and "A1+", though, as a result of unwillingness of certain actors of the promotion campaign to take part in this creative project (and not due to the fault of the media themselves), the level of representation of the sides in this project is questionable.

The majority of the studied broadcasters aspired to cover the campaign in the format of news, as well as through interviews. In certain cases debates were held. The journalists aimed to lead the debate into the field of discussion of the content of the draft. Here it is necessary to note that the whole period of the study was conventionally divided into three stages: October 26 - November 5, November 6-19 and November 20 - December 4, 2015 (for the methodology of the monitoring and the list of the studied media please see the sections "General Information on Monitoring" and "The Media Studied: Brief Overview"). While during the first stage of the monitoring statements of general political character and assessments of the procedure of the referendum dominated the coverage, later more attention was paid to the essence of the draft of amendments to the RA Constitution.

At the same time, the promotion campaign on television appeared too brief to secure maximum involvement of Armenian citizens into the process of constitutional reform. While the promotion campaign officially commenced on October 10, on television it de facto started almost a month later. Though nothing prevented Armenian media from covering the theme of amendments to the Constitution in their airtime before that, the decree of the RA Central Electoral Commission on the allocation of free and paid airtime for promotion through public broadcaster starting only from November 6, in a way became a guide for action for all the TV companies. And only on the third stage of the monitoring the share of editorial pieces devoted to the referendum exceeded 10% (10.2 %) of the total number of the studied pieces. Taking into account the promotion units, which also became lengthier closer to the day of the voting, it is possible to conclude that it was precisely in the last two

weeks that the theme of amendments to the Constitution became a major topic on the national channels. During the first and the second stages the coverage of the referendum made up 6.3% and 7.1%, respectively.

The problems in the legal-normative regulation and the legal practice of promotion campaign on referendums also influenced the level of representation of various interested groups in the air of the broadcasters. Though the six political parties, which have factions in the RA National Assembly were equally divided in their attitude to the constitutional reform (three parties, Republican Party of Armenia (RPA), "Prosperous Armenia" and Armenian Revolutionary Federation-Dashnaktsutyun supported the draft, and three parties, Armenian National Congress (ANC), "Orinats Yerkir" and "Heritage" were against it), closer to the end of the campaign the "yes" parliamentary camp kept gaining advantage over the "no" camp. According to the results of the whole monitoring period (October 26 - December 4), the coverage of the supporters of the reform exceeded the coverage of their opponents roughly 1.5 times, both in terms of airtime volume and references frequency.

The advantage of parliamentary forces supporting the constitutional reform in the volume of airtime also affected the balance of connotation references. During the three stages of the monitoring, within this conventional "first category" of participants of the promotion campaign, 248 statements in favor of the constitutional reform were recorded, as opposed to 153 statements criticizing the draft or calling for a vote against the reform.

This imbalance is compensated to a certain extent through TV channels' references to representatives of the conventional "second category" (independent MPs/nonparliamentary parties, civil society/expert community, representatives of initiatives formed in connection with the amendments to the RA Constitution, Vox Populi). Here, from 421 references to the theme of the referendum 74 had positive connotation, and 243 had negative connotation, and the balance in favour of negative views was recorded among all groups of this category, with the exception of the Vox Populi. Overall, taking all the groups of campaign participants together, in the studied programmes, the draft of the constitutional amendments as well as the referendum itself were mentioned 330 times with positive connotation, 396 times with negative connotation and 526 times with neutral connotation. Here it is important to stress that recorded connotation references did not include assessments of the procedure of the voting in the referendum, e.g. the issue of voting with ID cards that was intensively discussed in October. References to that matter. though among them harsh criticism prevailed, were recorded as neutral (and the airtime allocated to them was not recorded), since they did not contain a direct attitude to the Constitution amendments draft.

Speaking about "the second category" of participants, it is necessary to underline what was probably the main problem of the legal-normative regulation of the promotion campaign for the referendum. The recognition of parliamentary parties as the main actors of the campaign willingly or unwillingly served as a hint for several broadcasters that some of the stakeholders of the process can be overlooked. The same refers to allocation of paid airtime for promotion. Thus, during the whole period of the monitoring the studied programmes of "Armenia" TV channel never made any reference to the actions or positions, which were directly related to the constitutional amendments, of the initiatives "No pasaran!" and "New Armenia", even though these initiatives were formed specifically in connection to the referendum. The Second Armenian TV Channel and "Shant" did not allocate any coverage to the "No Pasaran!" initiative.

Another example of a negligent approach to commonly accepted principles of coverage of political campaigns was the "Triangle" programme on the PTA First Channel. The fact that the first issue of the programme was aired on November 6 (the day when promotion on television in fact began) and that two of its five issues were devoted to the constitutional reform, serves as indirect evidence that this weekly programme was linked to the referendum. The anchor of the discussion programme was the RA Minister of Education and Science, Armen Ashotyan, who is also the Vice-Chairman of the ruling RPA (the Chairman of the party and the author of the initiative of amendments to the RA Constitution is Armenia's President Serzh Sargsyan). Irrespective of the content of the programme and the role of the anchor in it, these circumstances allow viewing the "Triangle" in the airtime of the public broadcaster as an obvious precedent of conflict of interest.

As the day of the voting was becoming closer, the perception of RPA and ANC as the main debating sides was becoming more pronounced in the media. Throughout the whole period of the monitoring Republicans turned out to be the undisputed leaders in terms of the airtime allocated to them, and ANC not only found itself on the 2nd place among the parliamentary parties according to the cumulative indicator on all channels studied, but also received a larger volume of coverage than the two other parties from the "no" camp, "Heritage" and "Orinats Yerkir" together. Dashnaktsutyun, which during the first two monitoring stages was perceived as an actor with almost the same share of responsibility for the "yes" campaign as the RPA, received during the third stage almost 10 times less coverage than the Republicans. And "Prosperous Armenia" manifested passivity during the whole campaign, and, as a result, lagged behind significantly in terms of the volume of television coverage compared to all other parliamentary parties.

RPA secured a significant gap in coverage compared to other parties, mostly during the third conventional stage of the monitoring. And this was due to the broadcasting on December 3 of the interview given by the RA President Serzh Sargsyan to the representatives of Armenian TV channels, as well as news coverage of this event. Airtime allocated to that interview comprised 45% from the cumulative volume received by RPA in the programmes studied throughout the whole period of the monitoring (from October 26 to December 4). Overall, the coverage of this interview on the Second Armenian TV Channel comprised 49.7% of the cumulative airtime, allocated to all the six parliamentary parties through the whole period of the study, on "Shant" it amounted to 36.1%, on "Armenia" to 30%. This is enough to make it impossible to talk about equal (in quantitative terms) possibilities for participants of the promotion campaign to defend their positions. On three other channels the President's interview also received a significant share of the cumulative airtime of all parliamentary parties through the period of the study: "Yerkir Media" - 17.5%, "Kentron" - 13.9%, PTA First Channel - 11.7%.

The distribution of paid airtime, allocated for promotion, underlined the leadership in the "yes" and "no" campaigns of RPA and ANC, respectively. Promotion time, paid for by the Republicans, comprised almost 90% of total paid airtime used by the "yes" camp, as well as about two thirds of the cumulative paid airtime in the framework of the referendum promotion campaign on all the studied TV channels. ANC became the only one from the "no" camp that was able to pay for promotion in the airtime. These data suggest, first of all, significant advantage in resources of the ruling party, compared to all other Armenian political forces (only this party used paid airtime of all the six broadcasters studied, evenly throughout the whole period of the promotion campaign). And, second, these data show that prices for political promotion on television are unreasonably high in current conditions

(this conclusion is also supported by the fact that the most popular among the channels was the paid airtime of "Kentron" TV, which had relatively affordable prices).

As for the free promotion time, provided by the PTA First Channel, all parliamentary parties, except Dashnaktsutyun used it up to the limit, or were maximally close to the limit.

Actors, which were considered by the monitoring group as belonging to the conventional "third category" (media/journalists and government-level international organizations/official representatives of foreign countries) made fewer statements than others on the topic of the referendum. During the second (November 6-19) and third (November 20 - December 4) stages of the monitoring, the journalists in their own programmes voiced their own opinions about the constitutional amendments more often than during the first stage (October 26 - November 5). In the majority of cases they kept complete neutrality, which can be one of the positive characteristics of the campaign. The exception was an episode in the programme "Voice of Society" on "Yerkir Media", repeated on the next day, in which the editorial text contained positive attitude to the draft of amendments to the Constitution. The statements of representatives of international institutions about the draft amendments to the Constitution also included the positive opinions (in six cases, during all the three stages of the monitoring). This circumstance can be viewed as one-sided coverage of the position, in particular, of the Venice Commission, which had also critical comments regarding the constitutional amendments draft, however, not reflected in the coverage of the studied broadcasters.

According to the results of the whole period of the monitoring, "Kentron" TV channel manifested the highest degree of interest to coverage of the theme of the referendum among the studied media. While after the first stage it significantly lagged behind "Yerkir Media", after the second stage it came neck to neck with the leading channel, and after the third stage it was far ahead as compared to the other studied broadcasters in terms of the volume of coverage allocated to that topic. "Kentron" covered especially intensively the positions of the political segment of the participants of the promotion campaign, most of all the parliamentary political forces, while paying relatively little attention to the initiatives formed in connection with the process of the constitutional reform. At the same time opinions "for" and "against" were presented on that channel in a balanced way: 81 and 82, respectively.

"Yerkir Media", which during the last two weeks somewhat lowered the intensity of coverage of the theme of the referendum, in the end came second in terms of the volume of the airtime allocated to the topic. At the same time, this broadcaster remained more open than the others to representatives of civil society and experts: in the studied programmes of "Yerkir Media" this group surpassed the parliamentary parties according to the volume of coverage, while according to the frequency of references it conceded only to RPA and Dashnaktsutyun. This broadcaster accounted for almost half of the airtime (46%) of all studied TV channels, allocated to civil society and experts. Though the latter, as on other TV channels, made in most cases negative statements about the constitutional reform, the ratio of "yes" and "no" on "Yerkir Media", at the expense of parliamentary parties' statements, came to 72 to 63 in favour of supporters of the constitutional amendments draft. It is guite typical that on "Yerkir Media" "Prosperous Armenia" did not receive airtime for expressing its positions on the referendum. Coming back to "Kentron", here "Prosperous Armenia" gained almost no attention as well, receiving only 42 seconds of coverage. It is also worth noting that "Yerkir Media" consistently referred to opinions of "common citizens" (Vox Populi). "Kentron" allocated to that group almost as much time as "Yerkir Media", but these were reports about the results of sociologic polls.

First Channel of the Public Television of Armenia was the third in terms of airtime devoted to the theme of the referendum, with a significant gap separating it from the two leaders. However, in terms of frequency of references it surpassed all the studied broadcasters. Besides RPA, it covered relatively intensively ANC, "Heritage" and "Orinats Yerkir". The other two parties with parliamentary factions were far behind in terms of the volume of coverage. The PTA First Channel confirmed the general tendency of the studied TV channels: like the others it did not perceive the civic initiatives formed in connection with the process of constitutional amendments as participants of the campaign deserving attention and allocated an insignificant volume of editorial coverage to them. The balance of "yes" and "no" statements on the draft of constitutional amendments in the studied programmes of the public broadcaster was largely observed: 98 to 102, respectively.

During the third stage of monitoring "Armenia" TV channel significantly increased the lagging behind the PTA First Channel in volume of editorial airtime, devoted to the theme of the referendum. Throughout the whole period of monitoring, on this channel RPA and ANC surpassed significantly "Orinats Yerkir", which was the third according to this indicator. The other three political forces with factions in the National Assembly were far behind even "Orinats Yerkir". The civic initiatives formed in connection with constitutional amendments, as mentioned above, received no airtime on this channel at all, and were mentioned only 11 times during the 40 days of the monitoring. The ratio of connotation statements regarding the draft of the Constitution in the studied programmes of "Armenia" was 32:58 in favour of the negative ones.

Second Armenian TV Channel became more active on the third stage of the monitoring and somewhat surpassed "Shant" according to the editorial airtime allocated to the theme of the referendum and the frequency of references to it. RPA, Dashnaktsutyun and "Heritage" (from the parliamentary parties), as well as the group "independent MPs/non-parliamentary parties" received significantly more attention from this broadcaster than "Prosperous Armenia", ANC and "Orinats Yerkir". The civic initiative Front of Public Salvation "New Armenia" received on the Second Armenian TV Channel a larger volume of editorial airtime than on five other studied broadcasters together. Total balance of connotation references on this channel was 26:50 in favour of negative ones.

"Shant", like Second Armenian TV Channel, was significantly behind the four previous channels that had more or less actively covered the theme of the referendum. The three parliamentary parties (RPA, ANC and "Heritage") received a significant advantage in terms of editorial coverage over the three others ("Prosperous Armenia", "Orinats Yerkir" and Dashnaktsutyun), as well as over independent MPs and non-parliamentary political forces. However, since the "set" of parties having an advantage over others was different on each channel, the audience, as mentioned above, was able in general to get acquainted to all positions. "Shant" became the only one of the broadcasters studied, where representatives of the conventional "third category" (media/journalists and government-level international organizations/official representatives of foreign countries) did not make statements about the constitutional amendments at all. Total balance of positive and negative statements on that TV channel was in favour of the latter: 21 to 41. Thus, according to this indicator, the studied programmes of "Armenia", Second Armenian TV Channel and "Shant" contained the ratio of connotation references that was the least favourable for the Constitution draft.

The completed monitoring revealed the necessity for perfecting the legal-normative framework of the referendum promotion campaign and legal practice, for adjusting the editorial policies of broadcast media to make them more in line with the interests of

audience, as well as for a more effective application of professional norms and media self-regulation mechanisms. Besides, the quantitative data mentioned above, as well as the data contained in the tables attached, can become the basis for analysis of the social-political processes in the country, taking place within the context of the constitutional reform.

GENERAL INFORMATION ON MONITORING

Monitoring of Armenian broadcast media coverage of the December 6, 2015 referendum on amendments to the RA Constitution was administrated by Yerevan Press Club within the framework of the Joint Project between the European Union and the Council of Europe "Promote Professional and Responsible Journalism by Supporting Regional Network of Self-Regulatory Bodies". Monitoring was carried out during the period of the promotion campaign preceding the referendum, *from October 26 to December 4, 2015.* Preliminary results of the study were presented on a stage-by-stage basis: October 26 - November 5, 2015, November 6-19, 2015 and November 20 - December 4, 2015. After the completion of monitoring a final report, covering the entire period of the study, was published.

The monitoring aimed, through analysis of quantitative and qualitative data, to establish the following:

- to what extent in the programmes studied, as well as in the units of free or paid promotion related to the referendum relevant requirements of the RA legislation were accomplished;
- to what extent the programmes studied reflected the diversity of opinions regarding the draft amendments to the RA Constitution;
- to what extent the audience of Armenian TV channels in general and each of the TV channels in particular received an opportunity to get acquainted to various positions regarding the draft amendments to the RA Constitution.

Monitoring covered 6 national broadcast media:

- First Channel of Public Television of Armenia (h1)
- 5 private TV channels "Armenia", "Yerkir Media", "Kentron", Second Armenian TV Channel (h2) and "Shant".

On the above-mentioned TV channels the study covered the following:

- The main issues of news/news and analysis programmes, as well as current affairs/discussion programmes aired throughout the period of the promotion campaign (October 26 - December 4, 2015)
- The units of free or paid promotion related to the December 6, 2015 referendum, which were aired since *November 6* (when airtime for promotion was first allocated) to *December 4, 2015*.

The object of the monitoring were all TV pieces, which included any kind of reference to amendments to the RA Constitution made by representatives of various segments of society.

MONITORING METHODOLOGY

A. STUDY OF TV PROGRAMMES

I. The main unit of the study was **TV piece**.

The following was regarded as a TV piece:

The airtime unit, distinct in its theme, composition and design, i.e.:

- a separate story in the newscast;
- separate communication, presented by the programme host;
- a part (section, story) of the programme, touching on different issues/problems, made distinct by theme, composition and design (with a bloom, a jingle, etc.);
- introductory announcements of the pieces were viewed as a part of the story they referred to;
- the text of the host, introducing the TV piece (report, etc.), was viewed as a part of this piece (report, etc.).

Of these:

- **News/news and comment programmes** were divided into stories, and each story was treated as a separate independent piece;
- Current affairs/discussion programmes were treated in the following way:
- 1. If the programme was devoted to one topic/discussion, it was treated as one independent piece;
- 2. If the programme was tessellated, i.e., divided into independent thematic units, then every unit was treated as a separate independent piece.

II. Representatives of various segments of the society were classified according to three conditional categories, which, in their turn, were divided into groups.

The conditional "first category" consisted of one group:

The conditional "third category" included two groups:

1.	Media and journalists
2.	Government-level international organizations and official representatives of

- III. In the course of the monitoring the following was determined and recorded:
- 1. Total amount of TV pieces studied.
- 2. Amount of TV pieces devoted to the topic of the monitoring.
- **3.** References to the theme of the referendum by representatives of the groups belonging to the *first two conditional categories* were studied in the following way:
 - Measuring airtime (in seconds) allocated to statements of representatives of the groups regarding the amendments to the RA Constitution;
 - Counting the number of mentionings/citations (in units) of statements/positions of representatives of the groups on the amendments to the RA Constitution;
 - Determining **attitude** of the representatives of the groups to the amendments to the RA Constitution (in units) **positive** (+), **negative** (-) or **neutral** (0).

The term "connotational/sign" attitude (positive or negative) signified that the piece contained a statement/position by a representative of a group in support (+) or against (-) the draft of amendments to the Constitution, as well as its possible adoption.

At the same time the **connotation** of the attitude and **airtime** were recorded only in cases, when the material contained the opinion of a group representative concerning the content, specifics of the amendments, or if a clear position "for" or "against" the draft was voiced. If the representative of a group made a statement regarding the procedure of the referendum or aspects related to the procedure without voicing an evaluation of the content of the draft or a position regarding a "yes/no" vote, such statements (irrespective of whether they were sharply critical or clearly approving of the procedure) were assessed as neutral, and the airtime allocated to them was not recorded, since these statements did not refer to the main theme of the monitoring.

If a piece mentioned several representatives of various groups or of the same group, all those **mentionings** were recorded in the corresponding group with their attitude sign.

4. Groups of the *third conditional category* were studied in the following way:

- Measuring the airtime (in seconds) allocated for expression of opinion of group representatives regarding the amendments to the RA Constitution;
- Counting the number of **references** (in units) of group representatives regarding the amendments to the RA Constitution;
- Determining the **nature of references** of group representatives to the amendments to the RA Constitution (in units) **positive** (+), **negative** (-) or **neutral** (0).

Differentiation of the media/journalists and international organizations/official representatives of foreign countries as a separate category was conditioned by the specific role of these groups, which, by definition, were not sides of the discussion. The mission of the first ones is to be as unbiased as possible and provide complete, diverse and pluralistic information regarding the issues related to the constitutional amendments and the referendum, in order to help the voter to make a conscious choice. As for international/foreign institutions their goal has to be the assistance to the democratic transformations, cooperation on expert level, monitoring the ongoing processes.

Based on the above, **references** of representatives of those two groups to the theme of the referendum were recorded only in those cases when they made statements in their primary capacity (in particular, if the journalist appeared in the capacity of the author or the anchor of a TV programme). In all other cases the monitors classified them as belonging to other categories (groups): e.g. journalist, giving an interview, depending on the specific case and the way he was represented in the piece, could be classified as member of the expert community, civic initiative, etc.

B. STUDY OF THE UNITS OF FREE AND PAID PROMOTION

Units of free and paid promotion on the December 6, 2015 referendum were studied starting from the moment the TV channels allocated airtime to groups/group representatives for promotion: *from November 6 to December 4, 2015*. The date of the beginning of the promotion in the media was conditioned by the legal provision, prescribing allocation of public broadcaster airtime for promotion 30 days before the voting.

When determining the categories of studying advertisement units, the definition of groups, provided in the RA Law "On Referendum" as the ones who are able to lead the promotion, was used: "In relation to the issue submitted to referendum the right to campaign by means and manners not prohibited by law belongs to citizens of Republic of Armenia, the author of the initiative of referendum, factions (groups), parties and non-governmental organizations" (Clause 1, Article 20).

Methodology of this section of the monitoring was also based on the decree, approved by the Central Electoral Commission of the RA, according to which free and paid time for campaign promotion in the airtime of the public broadcaster was allocated to parliamentary factions.

Accordingly, in the course of the monitoring **airtime** (in seconds), allocated to the following categories (groups) for paid and free promotion, was recorded:

THE MEDIA STUDIED: BRIEF OVERVIEW

FIRST CHANNEL OF PUBLIC TELEVISION OF ARMENIA (h1) is a part of the Public TV and Radio Company, founded in 2001. The managing body is the Council of Public TV and Radio Company. The daily duration of air of the First Channel is 24 hours. The programmes of the channel can also be received abroad via satellite.
