**INTERIM REPORT ON THE MONITORING
OF ARMENIAN BROADCAST MEDIA COVERAGE
OF THE DECEMBER 6, 2015 REFERENDUM
ON AMENDMENTS TO THE RA CONSTITUTION
(November 6-19, 2015)**

In comparison to the first stage of the monitoring ([October 26 - November 5, 2015](#)) the following two weeks were more intense, in terms of editorial pieces, as well as in terms of direct campaigning in favor or against amendments to the RA Constitution. When it comes to cumulative editorial airtime, the intensity of coverage of the theme of the referendum from November 6 to November 19, 2015 increased roughly 2.5 times as compared to the previous 11 days of the study. At the same time the problems that exist in the field of normative-legislative regulation of promotion campaign for referendums and legal practice manifested themselves more vividly during this period.

Throughout the period in question (November 6-19) we noted an increase in the gap between opportunities of various parliamentary factions to state their position on the theme of the referendum on the TV channels studied (*for the methodology of the monitoring and the list of the media studied, please consult the section “General Information on Monitoring”*). Though the 6 political parties, represented in the National Assembly of Armenia, have been, roughly speaking, divided into two equal groups (three parties support voting “yes” and three parties support voting “no”), the supporters of “yes” received a little more than 56% of the editorial airtime, allocated to this conventional category of campaign participants. Meanwhile, during the first stage of the monitoring (October 26 - November 5) the airtime coverage of the parliamentary factions in the context of the referendum was more balanced. Moreover, during the second stage of the monitoring, in terms of frequency of references, the parliamentary camp “yes” has surpassed its opponents even more vigorously: 152 against 92. Of the forces that supported the Constitutional reform, the main load of explaining their position to the society was taken by the Republican Party of Armenia (RPA) and Armenian Revolutionary Federation-Dashnaktsutyun. “Prosperous Armenia” party is leading a quite passive media campaign.

In the opposing camp the Armenian National Congress (ANC) has the largest presence in the media in terms of the volume of the cumulative editorial airtime during the first two stages of the study (October 26 - November 19). The parties that follow, “Orinats Yerkir” and “Heritage” are significantly behind the ANC even if the time allocated to both on the studied channels is summed up.

The advantage in the volume of airtime of those parliamentary political forces who support the reform of the Constitution was reflected in the ratio of connotation references. During both stages of the monitoring 131 statements were recorded in favor of the amendments by representatives of this conventional category of campaign participants, as opposed to 70 statements that either rejected the amendments or called for voting against them in the referendum.

This ratio to a certain extent was compensated by references of the TV channels to representatives of the conventional “second category” (independent members of

parliament/ non-parliamentary parties, civil society/expert community/non-formal activists, representatives of initiatives formed in connection with the amendments to the RA Constitution, and Vox Populi). Here, of 204 references to the referendum, 34 had a positive connotation and 115 had a negative connotation; advantage of negative references was recorded in all groups of this category, with the exception of the Vox Populi. Here it is important to stress that assessments of the procedure of the referendum, including the actively discussed October issue of voting with ID cards, were not recorded as connotation references. References to this issue, even though sharp criticism prevailed among them, were recorded as neutral (and the airtime allocated to them was not recorded), since they did not contain direct attitude to the draft of amendments to the Constitution.

Simultaneously, during the period from November 6 to November 19, the lack of attention of TV channels towards initiatives formed in connection with the constitutional amendments became even more obvious than during the previous stage. Representatives of the initiative “No pasaran!” in this period did not receive any airtime on any of the studied programmes. This circumstance can be interpreted as an indirect proof of imperfection of the normative-legislative basis, which almost exclusively regards the parliamentary factions as participants of the promotion campaign in broadcast media.

Distribution of paid airtime allocated for campaign has further exacerbated the gap between the two camps: the volume of airtime used in this way by the supporters of the reform exceeded the paid airtime of their opponents 26 times. Moreover, RPA alone has paid 10 times more for campaign airtime than the other five parliamentary factions altogether. This shows that the financial resources possessed by the ruling political force are incomparable with those of all other political forces. From the point of view of legislation here again we are dealing with the problem of limiting the number of campaign participants to the parliamentary factions. Apparently, the TV companies perceived the relevant provision of the decision of the RA Central Electoral Commission in such a way that allocation of airtime in paid promotion units to other interested citizens and associations was inadmissible. This can be considered one of the most serious problems of the current campaign.

The conventional “third category”, defined by the monitoring group for the purposes of this study as the category that includes media/journalists and government-level international organizations/official representatives of foreign countries, in both stages made less statements on the theme of the monitoring than other groups. During the period from November 6 to November 19 the journalists in their programmes expressed their own opinion about the amendments to the Constitution more often, keeping complete neutrality, which can be considered one of the positive characteristics of the campaign. Meanwhile, there were cases when representatives of international organizations expressed not only neutral but also positive opinions about the Constitution draft (5 cases during the two stages).

From the point of view of content, the TV coverage related to theme of the referendum became more diverse during the second stage of the study (November 6-19). While during the previous 11 days the discussion was mostly limited either to the transition to parliamentary form of governance, or to issues of voting procedure, during the next two weeks other aspects of the Constitution draft were also addressed.

Among the media studied the TV channel “Yerkir Media” continues to manifest the highest degree of interest to covering the topic of the referendum. It proved to be the most open

for experts and civil society representatives, who, during the two stages of the monitoring, received on this channel about three quarters of their airtime on all 6 channels studied. This group received twice as much coverage on “Yerkir Media” (in most cases voicing a negative position on the amendments) than ARF-Dashnaktsutyun, which was the leader in the conventional category of parliamentary factions. “Prosperous Armenia” party, even though it was mentioned in the context of the referendum, did not receive airtime for expressing its position on this TV channel. Representation of ANC on this channel was also limited and from the “no” camp it was the “Heritage” party that received the most airtime. By the way, “Heritage” faction is the only parliamentary faction, representatives of which have spoken out for (both times on “Yerkir Media”) and against the amendments in the media studied. In both stages “Yerkir Media” kept the overall balance of statements for and against the suggested amendments to the Constitution: 33 and 32 accordingly.

During the second stage of the monitoring “Kentron” became significantly more active, which allowed it to come very close to “Yerkir Media” in terms of editorial airtime devoted to the theme of the monitoring. According to the results of both stages of the monitoring, this channel has surpassed all others in providing opportunities for statements both to parliamentary political forces and independent MPs/non-parliamentary parties. The highest degree of attention here was received by the ANC, but as a result of active presence of ARF-Dashnaktsutyun and RPA on this channel, the overall balance of connotation references was in favor of the “yes” camp: 46 for the “yes” campaign, 36 for the “no” campaign. “Orinats Yerkir” still had no airtime on “Kentron”. “Prosperous Armenia” was also represented quite modestly.

The First Channel of Public Television of Armenia was the third (during both stages) with a big gap separating it from the two leaders. Among parliamentary political forces the highest volume of its airtime was received by “Heritage”, followed by RPA and “Orinats Yerkir”. The other three factions lagged far behind according to this indicator. The PTA First Channel supported the general trend among the studied channels: refusing to perceive the civic initiatives formed in connection with the amendments to the RA Constitution as actors of the campaign who deserve attention and therefore providing them with an insignificant amount of editorial coverage. Overall, the public broadcaster kept the balance of statements for and against the amendments to the Constitution: 37:38 accordingly.

According to the volume of editorial airtime “Armenia” TV channel lags behind the PTA First Channel insignificantly (based on the results of the first two stages of the monitoring). Here, as on “Kentron”, ANC received the highest volume of editorial coverage of all parliamentary political forces, followed by RPA. The other four factions are lagging behind strongly according to this indicator, while civic initiatives formed in connection with the constitutional amendments received no airtime at all on this channel and were mentioned only four times during the 25 days of the monitoring. The balance of connotation references was 26:29 in favor of negative references.

“Shant” lags behind significantly from the four studied channels that had covered the theme of referendum more or less actively. On “Shant” the parliamentary political forces, as well as other categories of campaign participants received a quite limited volume of coverage from October 26 to November 19, while the conventional “third category” (media/journalists and government-level international organizations/official representatives of foreign countries) did not express any opinions on the constitutional amendments. The coverage leader, albeit with quite modest results, was RPA. At the same time, the overall

balance between positive and negative statements on the Constitution draft was in favor of the latter: 17:24.

Second Armenian TV Channel, unlike the other studied broadcasters, lowered its already low level of activity of coverage of the theme of the referendum during the period of November 6-19. According to the results of both stages, it turned out to be the obvious outsider in terms of coverage of the process of constitutional amendments. Of all groups of the campaign participants the highest volume of editorial airtime was received by the initiative Front of Public Salvation "New Armenia". And the overall balance of connotation statements was 11:26 in favor of the negative ones.

While all parliamentary factions are trying to use the free airtime of special units for campaign promotion on the PTA First Channel, significant volume of the paid airtime, both on the public broadcaster and on the private ones, are accessible only to the RPA, due to its financial capabilities. RPA, which had dominated these units on all the 6 channels studied, became the only political force that had paid for its campaigning on "Shant" and Second Armenian TV Channel during the period studied (November 6-19). On three other channels, apart from RPA, two other parties were represented, albeit in modest volumes: "Prosperous Armenia" (on PTA First Channel) and ARF-Dashnaksutyun (on "Armenia" and "Yerkir Media"). Only on "Kentron" three parliamentary parties had paid for their promotion, RPA, ANC and ARF-Dashnaksutyun, though again in significantly different amounts.

GENERAL INFORMATION ON MONITORING

Monitoring of Armenian broadcast media coverage of the December 6, 2015 referendum on amendments to the RA Constitution is administrated by Yerevan Press Club within the framework of the Joint Project between the European Union and the Council of Europe “Promote Professional and Responsible Journalism by Supporting Regional Network of Self-Regulatory Bodies”. Monitoring is carried out during the period of the promotion campaign preceding the referendum, **from October 26 to December 4, 2015**. Preliminary results of the study are presented on a stage-by-stage basis: October 26 - November 5, 2015, November 6-19, 2015 and November 20 - December 4, 2015. After the completion of monitoring a final report, covering the entire period of the study, is published.

The monitoring aims, through analysis of quantitative and qualitative data, to establish the following:

- to what extent in the programmes studied, as well as in the units of free or paid promotion related to the referendum relevant requirements of the RA legislation have been accomplished;
- to what extent the programmes studied have reflected the diversity of opinions regarding the draft amendments to the RA Constitution;
- to what extent the audience of Armenian TV channels in general and each of the TV channels in particular has received an opportunity to get acquainted to various positions regarding the draft amendments to the RA Constitution.

Monitoring covered 6 national broadcast media:

- First Channel of Public Television of Armenia (h1)
- 5 private TV channels - “Armenia”, “Yerkir Media”, “Kentron”, Second Armenian TV Channel (h2) and “Shant”.

On the above-mentioned TV channels the study covered the following:

- The main issues of news/news and analysis programmes, as well as current affairs/discussion programmes aired throughout the period of the promotion campaign (**October 26 - December 4, 2015**)
- The units of free or paid promotion related to the December 6, 2015 referendum, which were aired since **November 6** (when airtime for promotion was first allocated) **to December 4, 2015**.

The object of the monitoring were all TV pieces, which included any kind of reference to amendments to the RA Constitution made by representatives of various segments of society.

MONITORING METHODOLOGY

A. STUDY OF TV PROGRAMMES

I. The main unit of the study was **TV piece**.

The following was regarded as a TV piece:

The airtime unit, distinct in its theme, composition and design, i.e.:

- a separate story in the newscast;
- separate communication, presented by the programme host;
- a part (section, story) of the programme, touching on different issues/problems, made distinct by theme, composition and design (with a bloom, a jingle, etc.);
- introductory announcements of the pieces were viewed as a part of the story they referred to;
- the text of the host, introducing the TV piece (report, etc.), was viewed as a part of this piece (report, etc.).

Of these:

- **News programmes** were divided into stories, and each story was treated as a separate independent piece;
- **Current affairs/discussion programmes** were treated in the following way:
 1. If the programme was devoted to one topic/discussion, it was treated as one independent piece;
 2. If the programme was tessellated, i.e., divided into independent thematic units, then every unit was treated as a separate independent piece.

II. Representatives of various segments of the society were classified according to three conditional categories, which, in their turn, were divided into groups.

The conditional “**first category**” consisted of one group:

Factions/parties represented in the National Assembly of Armenia	“Republican” (Republican Party of Armenia, RPA)

	"Armenian National Congress"
	"Orinats Yerkir"
	“Armenian Revolutionary Federation-Dashnaktsutyun”

The conditional “**second category**” included four groups:

1.	Independent members of National Assembly of Armenia and non-parliamentary parties
2.	Civil society, expert community, non-formal civic activists
3.	Representatives of initiatives formed in connection with the amendments to the RA Constitution: Civic Initiative “No pasaran!” and Front of Public Salvation “New Armenia”
4.	Vox Populi

The conditional “**third category**” included two groups:

1.	Media and journalists
2.	Government-level international organizations and official representatives of foreign countries

III. In the course of the monitoring the following was determined and recorded:

1. Total amount of TV pieces studied.

2. Amount of TV pieces devoted to the topic of the monitoring.

3. References to the theme of the referendum by representatives of the groups belonging to the **first two conditional categories** were studied in the following way:

- Measuring **airtime** (*in seconds*) allocated to statements of representatives of the groups regarding the amendments to the RA Constitution;
- Counting the number of **mentionings/citations** (*in units*) of statements/positions of representatives of the groups on the amendments to the RA Constitution;
- Determining **attitude** of the representatives of the groups to the amendments to the RA Constitution (*in units*) - **positive (+)**, **negative (-)** or **neutral (0)**.

The term “connotational/sign” attitude (positive or negative) signifies that the piece contains a statement/position by a representative of a group in support (+) or against (-) the draft of amendments to the Constitution, as well as its possible adoption.

At the same time the **connotation** of the attitude and **airtime** were recorded only in cases, when the material contained the opinion of a group representative concerning the content, specifics of the amendments, or if a clear position “for” or “against” the draft was voiced. If the representative of a group made a statement regarding the procedure of the referendum or aspects related to the procedure without voicing an evaluation of the content of the draft or a position regarding a “yes/no” vote, such statements (irrespective of whether they were sharply critical or clearly approving of the procedure) were assessed as neutral, and the airtime allocated to them was not recorded, since these statements did not refer to the main theme of the monitoring.

If a piece mentioned several representatives of various groups or of the same group, all those **mentionings** were recorded in the corresponding group with their attitude sign.

4. Groups of the **third conditional category** were studied in the following way:

- Measuring the **airtime** (*in seconds*) allocated for expression of opinion of group representatives regarding the amendments to the RA Constitution;
- Counting the number of **references** (*in units*) of group representatives regarding the amendments to the RA Constitution;
- Determining the **nature of references** of group representatives to the amendments to the RA Constitution (*in units*) - **positive (+)**, **negative (-)** or **neutral (0)**.

Differentiation of the media/journalists and international organizations/official representatives of foreign countries as a separate category was conditioned by the specific role of these groups, which, by definition, are not sides of the discussion. The mission of the first ones is to be as unbiased as possible and provide complete, diverse and pluralistic information regarding the issues related to the constitutional amendments and the referendum, in order to help the voter to make a conscious choice. As for international/foreign institutions their goal has to be the assistance to the democratic transformations, cooperation on expert level, monitoring the ongoing processes.

Based on the above, **references** of representatives of those two groups to the theme of the referendum were recorded only in those cases when they made statements in their primary capacity (in particular, if the journalist appeared in the capacity of the author or the anchor of a TV programme). In all other cases the monitors classified them as belonging to other categories (groups): e.g. journalist, giving an interview, depending on the specific case and the way he was represented in the piece, could be classified as member of the expert community, civic initiative, etc.

B. STUDY OF THE UNITS OF FREE AND PAID PROMOTION

Units of free and paid promotion on the December 6, 2015 referendum were studied starting from the moment the TV channels allocated airtime to groups/group representatives for promotion: **from November 6 to December 4, 2015**. The date of the beginning of the promotion in the media was conditioned by the legal provision, prescribing allocation of public broadcaster airtime for promotion 30 days before the voting.

When determining the categories of studying advertisement units, the definition of groups, provided in the RA Law “On Referendum” as the ones who are able to lead the promotion, was used: “In relation to the issue submitted to referendum the right to campaign by means and manners not prohibited by law belongs to citizens of Republic of Armenia, the author of the initiative of referendum, factions (groups), parties and non-governmental organizations” (Clause 1, Article 20).

Methodology of this section of the monitoring was also based on the order, approved by the Central Electoral Commission of the RA, according to which free and paid time for campaign promotion in the airtime of the public broadcaster is allocated to parliamentary factions.

Accordingly, in the course of the monitoring **airtime** (*in seconds*), allocated to the following categories (groups) for paid and free promotion, was recorded:
